### FIRE PREVENTION

With the onset of fall and winter, fire prevention in Kenmure becomes extremely important as a fire may spread quickly. Please consider the following:

1. Are your heating system and generator in proper working order?



2. Is there ample air circulation around appliances that are likely to overheat?

3. Is your kitchen oven hood free and clear of greasy build up that could cause a fire?

4. Is your dryer vent clear of lint that could cause a fire?

5. Are there any overloaded circuits, long extension cord runs or too many devices plugged into one outlet?

6. Are your fireplace and chimney free of dangerous build-ups that could catch fire or is a gas fireplace or gas grill inspected for dangerous leaks yearly?

7. Are smoke and carbon monoxide detectors installed on all levels and the garage, tested regularly and batteries replaced at least annually?

8. Are there properly charged, working fire extinguishers in the kitchen, basement, garage or other appropriate area?

9. Do you sleep with the bedroom door closed to prevent the spread of smoke and fire?

10. Do you have a known escape route and designated place to meet outside?

11. Do you know whom to call to get help in an emergency?



The KPOA Security Committee would like to remind our residents of some important rules and concerns we feel need to be reiterated from time to time.

HOLIDAY TRASH COLLECTION SCHEDULE: Please be reminded that our trash collection service recognizes six holidays during the year on which it does not collect trash: New Year's Day, Memorial Day, July 4, Labor Day, Thanksgiving Day, and Christmas. When any one of these holidays fall on Monday, trash collection will be on the following Tuesday.

#### REVIEW OF SECURITY GUARD GENERAL DUTIES:

The primary role of the security force is to provide access control at the Kenmure gate and to conduct routine security patrols. The security guards do not have police authority. In addition to their primary duties, from time to time, the guards have been willing to provide small services to residents outside their normal duties. The Security Committee has reviewed this area and established guidelines for such services that will and will not be provided at the Gatehouse.

### Security guards will:

- accept envelopes (8" x 11") and small packages containing papers and items of nominal value for pick-up by another resident or nonresident (with appropriate identification),
- accept and sign for FedEx, UPS, and other courier packages when the resident is not at home to sign for an item. *Guards will not be responsible for lost or damaged items.* <u>NOTE</u>: The resident must retrieve any such package in a timely manner, preferably on the day

received--the Gatehouse does not have the space to store packages for residents,

• accept and/or hold house keys for pick-up by another resident, visitor, or contractor with written permission to pick-up/use the key provided to Gatehouse security.

### Security guards will NOT:

- accept cash or valuables for pick-up by another resident or nonresident,
- access private residences for any reason. Other than for the key exchange option listed above, residents are responsible for arranging to provide access to their residences when they are not at home for such things as cleaning or repair services. For more extensive services, such as "house or pet sitting" services, the Visitor Authorization Form must be completed and left at the Gatehouse to authorize entry of a visitor if you are not at home,
- respond to complaints about "noisy neighbors" or lost/nuisance animals including but not limited to pets and bears,
- remove or dispose of animal carcasses or other objects from the roadways.
